# ***Reminding the Nullifying of legal authority*** **of all Corporate Police and Law Enforcement Agencies in** **the World**

*Issued to all corporate police officers and pretense government officials*

**LET IT BE KNOWN** as of September 10, (1)2017, under the Baltic Sea indigenous Court X decision of September 9, (1)2017

**LET BE FURTHER KNOWN that in disregarding this ORDER OF REVOCATION you are considered personally responsible**

This order is in effect as of 12:50 on September 9, (1)2017 and supersedes all statutes and orders of the convicted criminal bodies related to the corporate governments of the world.

THIS ORDER is issued by the Baltic Sea Indigenous Court under its authority as a dejur court of record convened under Natural Law according to the will and divine rights of the People, heirs of creation, and under the mandate of the Court's office at Earth District – to rescue all Life and the Living.

to find **999 ha of land in each community** for the indigenous life style

to build **indigenous tempels and schools** and install the priests of the living Gods .
